

## **FOUNDATION**

The Swellendam Bursary Fund was founded on 25 October 2005  
Established.

## **NETWORK**

To commemorate the lives of 21 learners, 6 teachers and the vehicle driver, who died in the Swellendam Bus disaster on 25 October 1975.

## **PURPOSE**

To provide scholarships to deserving post-matric students of the Swellendam Municipal Area Studying at a College or University – on the basis of no discrimination based on race, language, religion, or gender.

## **CONDITIONS**

- The parents/guardians' joint monthly income may not exceed R15 000;
- Bursary holders must during the year in which they receive a bursary from the Bursary Fund, do for at least a week of voluntary community service;
- No scholarships are awarded to previous bursary holders who have completed the academic year in question, failed and/or did not meet the required amount voluntary community service.

## **REDE**

Om die lewens van 21 leerders, 6 onderwysers en die voertuigbestuurder, wat op 25 Oktober 1975 in die Swellendam Busramp gesterf het, te gedenk.

## **DOEL**

Om beurse te voorsien aan verdienstelike post-matriek studente van die Swellendam Municipale Gebied wat aan 'n kollege of universiteit studeer - op die basis van geen diskriminasie gegrond op ras, taal, godsdiens of geslag nie.

## **VOORWAARDEN**

- Die ouers/voogde se gesamentlike maandelikse inkomste mag nie R15 000 oorskry nie;
- Beurshouers moet gedurende die jaar waarin hulle 'n beurs van die Beursfonds ontvang, vir minstens 'n week vrywillige gemeenskapsdiens doen;
- Geen beurse word toegeken aan vorige beurshouers wat die betrokke akademiese jaar gedruip het en/of nie die vereiste vrywillige gemeenskapsdiens gedoen het nie.

## **FUND AGGREGATION AND OTHER FACTS**

- Money is raised through functions and donations from donors.
- The Fund currently awards ±40 bursaries of R3 000 each at a cost of R120 000 per annum.
- Since the Fund's inception until September 2024, it has already **spent R2 428 248.78** to enable 332 students to enrol at a higher or further educational institution.
- More than 200 have already completed their studies or found jobs that match their academic background.
- Although job opportunities in Swellendam are limited, quite a few of them have returned to fill positions in the tourism industry and local government or to serve the local community as teachers or community workers.
- The Bursary Fund has helped many young people and their families to escape the grip of poverty and significantly raise their standard of living.

## **FONDSINSAMELING EN ANDER FEITE**

- Die Fonds ken tans ±40 beurse van R3 000 elk teen 'n koste van R120 000 per jaar toe.
- Sedert die Fonds se ontstaan tot September 2023 het dit reeds **R2 428 248.78** gespandeer om 332 studente in staat te stel om aan 'n hoër of verdere onderwysinrigting in te sny.
- Meer as 200 het reeds hul studies voltooi of betrekkings gevind wat by hul akademiese agtergrond pas.
- Alhoewel werkgeleenthede in Swellendam beperk is, het 'n hele paar van hulle teruggekeer om poste in die toerismebedryf en plaaslike regering te vul of om as onderwysers of gemeenskapswerkers die plaaslike gemeenskap te dien.
- Die Beursfonds het baie jongmense en hul families gehelp om uit die greep van armoede te ontsnap en hul lewenstandaard aansienlik te verhoog.
